



Top View Pin-Out





Pulse Power Dissipation







Typical Electrical Characteristics




$V_{\text{CE(SAT)}} v I_{\text{C}}$




Ic - Collector Current (Amps)

I_C - Collector Current (Amps) $V_{BE(ON)} v I_C$








Suggested Pad Layout
